Non-profit organizations and charitable foundations require accountants to maintain financial records, prepare reports, and ensure transparency in transactions. Graduates may choose to work as freelancers or with small outsourcing firms, and with the rise of fintech, there is increasing demand for accountants skilled in developing and implementing financial technologies. Moreover, opportunities exist in international companies or organizations involved in business with or within Ukraine, particularly in international accounting and reporting.
